In addition to the above, the Board of Directors and the Shareholders, in their meetings held on 5th September, 2019 and 5th October, 2019, had also approved issuance of 100,000,000 Equity Shares to Jomei Investments Limited for an aggregate consideration of Rs. 10,000 million which is subject to applicable regulatory approvals and shall be undertaken once such approvals are received.

Consequently, the issued, subscribed and paid-up equity share capital of the Company stands increased from Rs. 22,02,55,77,660 (divided into 2,20,25,57,766 equity shares of face value Rs.10/- each) to Rs. 23,12,55,77,660 (divided into 2,31,25,57,766 equity shares of face value Rs.10/- each).
