Stocks to buy in 2024, AB Capital share price: On the last day of the week, shares of the Aditya Birla Capital Limited (ABCL) opened at Rs 187.95 apiece on the BSE and closed at Rs 187.55. The stock touched an intraday high of Rs 189.10 and an intraday low of Rs 182.05. At the current price, the market capitalisation of the company is Rs 48,600 crore.

Incorporated in the year 2007, Aditya Birla Capital is a large cap company operating as the holding company for the financial services businesses of the Aditya Birla Group. Institutional broker Motilal Oswal attended an analyst meet held by the Aditya Birla Capital's board, and now they have a BUY call on it.

Motilal Oswal, in their report, said, "Unlike other Analyst Meets, ABCL's meet shifted its focus from outcomes to means (or capabilities). This approach aims to fortify ABCL's businesses with a strong foundation for sustained execution."

"Among non-banks, Aditya Birla Capital is rapidly emerging as one of the most adept in terms of capabilities across sourcing (prospecting), underwriting (onboarding), and collections (renewals) within in its lending (protection) businesses." the broker noted in its report.
